## CITY OF WESTMINSTER RESOLUTION NO. XXXX

## A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, CALIFORNIA, ESTABLISHING THE ARTICLE XIIIB APPROPRIATION LIMIT FOR THE 2025-26 FISCAL YEAR

WHEREAS, Article XIII B of the California Constitution requires the City Council to set the spending limitation from proceeds of taxes for fiscal year 2025-26 according to the formula in said Article, as amended; and

WHEREAS, an amendment to Article XIII B stipulates that the spending limitation may be adjusted from the prior fiscal year based on population and inflation factors as selected by vote of the legislative body; and

WHEREAS, the appropriation limit annual adjustment factor options include:

- 1. The growth in the California Per Capita Income, or the growth in the nonresidential assessed valuation due to new construction within the city; and
- 2. Population growth of the City, or population growth within the County of Orange.

WHEREAS, the applicable factor for the California Per Capita Income increased 6.44 percent compared to an increase of 0.48 percent non-residential assessed valuation due to new construction within the city; and

WHEREAS, population within the city increased 0.13 percent compared to the population increase within the county of 0.17 percent.

NOW, THEREFORE, BE IT RESOLVED that the appropriation limit for fiscal year 2025-26 has been calculated based on the adjusted prior year limit increased by the greater of the percentage growth in population of the city or the county and in the increased percentage of California Per Capita Income from the preceding year as follows:
