A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, CALIFORNIA, REVISING RESOLUTION NO. 5345, AMENDING THE SALARY SCHEDULES FOR THE WESTMINSTER POLICE OFFICERS' ASSOCIATION FOR THE PERIOD OF JULY 1, 2026, THROUGH AND INCLUDING JUNE 30, 2029

WHEREAS, California Government Code Section 20636 and California Code of Regulations Section 570.5 require California Public Employee Retirement System member agencies to maintain and publicly post publicly available pay schedules; and

WHEREAS, the City Council desires to amend the title of the position of "Police Commander" to "Police Lieutenant"; and

WHEREAS, Exhibit A to be implemented on July 11, 2026, attached hereto is a Salary Schedule for all City of Westminster full-time Westminister Police Officers' Association; and

WHEREAS, Exhibit B to be implemented on January 9, 2027, attached hereto is a Salary Schedule for all City of Westminster full-time Westminister Police Officers' Association; and

WHEREAS, Exhibit C to be implemented on July 10, 2027, attached hereto is a Salary Schedule for all City of Westminster full-time Westminister Police Officers' Association; and

WHEREAS, Exhibit D to be implemented on July 8, 2028, attached hereto is a Salary Schedule for all City of Westminster full-time Westminister Police Officers' Association.

THE CITY COUNCIL OF THE CITY OF WESTMINSTER HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby approves the attached salary schedules A, B, C and D which includes the title change from "Police Commander" to "Police Lieutenant".

SECTION 2. The City Manager is authorized to make such modifications, corrections and changes to the adopted salary schedules as necessary to correct any technical or drafting errors or to otherwise accurately reflect Council intent in

adopting the salary schedules.

SECTION 3. The Mayor shall sign as to passage, approval, and adoption of this Resolution.

SECTION 4. The City Clerk shall certify to the passage and adoption of this Resolution and shall affix their signature and City Seal and that same shall be entered into the Book of Resolutions.
