AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, CALIFORNIA, TO AMEND SECTION 10.64.020 OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE WESTMINSTER MUNICIPAL CODE CONCERNING SPEED LIMITS IN WITHIN THE CITY

THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Municipal Code Amendment. Westminster Municipal Code Section 10.64.020 (State Speed Limit – Decrease in Certain Zones) is hereby amended to read as follows:

It is determined upon the basis of the 2026 update to the City of Westminster Engineering and Traffic Survey that the speed permitted by state law outside of business and residence districts as applicable upon the following streets is greater than is reasonable or safe under the conditions found to exist upon such streets, and it is declared that the prima facie speed limit shall be as set forth in this section on those streets or parts of streets designated when signs are erected giving notice thereof.

SECTION 2. Certification. The City Clerk certifies that the Mayor and City Council introduced and conducted first reading on the 13th day of May 2026. The City Clerk further certifies that the Mayor and City Council at its regular meeting on the XXth day of XXXX 2026, conducted second reading, passed, and adopted Ordinance No. XXXX and shall affix their signature and City Seal and that same shall be entered into the Book of Ordinances.

SECTION 3. Attestation. The Mayor shall sign and the City Clerk shall attest to the passage of this Ordinance. The City Clerk shall cause the same to be published once in the official newspaper within 15 days after its adoption. This Ordinance shall become effective 30 days from its adoption.
