## Report

#### **Measures Y and E History**

On November 8, 2023, residents of Westminster approved Measure Y, a no-tax increase local services ballot measure to adopt a new one-cent (1%) transaction and use tax replacing the expiring Measure SS, which ended December 31, 2022. Measure Y collections began on April 1, 2023, and will last for 20 years, until March 31, 2043.

During the Special Election held on March 5, 2024, the residents of Westminster voted and approved the passing of Measure E (Safety, Services and Stabilization Measure) to adopt a new half-cent (1/2%) transaction and use tax. Measure E collections began July 1, 2024, and will continue until ended by voters.

### **Citizen Oversight Committee**

Consistent with the City's ongoing commitment to citizen involvement as a fundamental principle of good government, specific citizen oversight and fiscal accountability, the adopted Ordinance for both Measures Y and E included a provision for a citizens oversight committee appointed by City Council to meet twice a year to review and discuss the use of the revenue generated by the measures.

The Measures Y and E Citizens Oversight Committee has the following responsibilities:

 Review of the City's annual audited financial report, specifically related to the use of funds generated through Measures Y and E.

- Review general fund revenue and expenditures related to the use of funds generated through Measures Y and E included in the City's annual budget report.
- Report to the City Council regarding their findings following the review of the annual audited financial report and the annual budget report.

The Citizens Oversight Committee is comprised of Westminster residents appointed by the City Council. Committee Member Tony Bui, appointed by Councilmember NamQuan Nguyen resigned from his position on the committee. Councilmember NamQuan Nguyen appointed Thanh Dang to fill the position. The committee members are:

#### **Measure Y and E Revenues and Expenditures**

The Citizens Oversight Committee has completed a review of financial reports detailing the revenues and expenditures of Measures Y and E funds. Revenues from the measures are collected by businesses and remitted to the California Department of Tax and Fee Administration (CDTFA), and then the CDTFA sends these funds to the City.

The revenue for both measures is accounted for in the general fund. Together, these sources help fund overall general fund expenditures. These include police, fire, public works, community services, community development, and general city administration. Transaction use tax revenue also allows the general fund to contribute \$1.5 million to

street improvements annually. This practice started with the passage of Measure SS. To date, \$13.5 million has been allocated to street improvements.

The FY 2025-26 Adopted Budget was the first balanced general fund budget in six years. The budget includes nine new positions, six in the general fund, and contributed \$249.8 thousand to reserves.
