A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF WESTMINSTER, CALIFORNIA,
REVISING RESOLUTION NO. 5234, AMENDING THE
SALARY SCHEDULE FOR THE WESTMINSTER
MUNICIPAL EMPLOYEES' ASSOCIATION (WMEA) FOR
THE PERIOD OF JULY 1, 2023, THROUGH AND
INCLUDING JUNE 30, 2026.

WHEREAS, California Government Code Section 20636 and California Code of Regulations Section 570.5 require California Public Employee Retirement System member agencies to maintain and publicly post publicly available pay schedules; and

WHEREAS, the City Council desires to amend the "Westminster Municipal Employees Association (WMEA) Salary Schedule" to include the position of "Building Inspector";

SECTION 1. Effective July 12, 2025, the Westminster Municipal Employees Association (WMEA) Salary Schedule is updated as shown in Exhibit A to this Resolution.

SECTION 3. The City Clerk shall certify to the passage and adoption of this Resolution and shall affix their signature and City Seal and that same shall be entered into the Book of Resolutions.
