A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER PROVIDING FOR NO PARKING OR STOPPING AT A CERTAIN LOCATION ON THE WEST SIDE OF MAGNOLIA STREET SOUTH OF WESTMINSTER BOULEVARD

WHEREAS, the Traffic Commission has recommended that parking and stopping be prohibited at a certain location on the west side of Magnolia Street, south of Westminster Boulevard; and

WHEREAS, the Mayor and City Council find that parking and stopping should be prohibited at said location.

NOW, THEREFORE, THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER HEREBY RESOLVE AS FOLLOWS:

<u>SECTION 1.</u> Parking restrictions shall be installed on the west side of Magnolia Street, south of the end of curb return at Westminster Boulevard, from 1125 feet to 1245 feet, 1272 feet to 1297 feet, and 1350 feet to 1405 feet, for a total distance of 200 feet.

<u>SECTION 2.</u> The Traffic Engineer is hereby directed to install the appropriate signs and/or markings at said location as recommended.

<u>SECTION 3.</u> The City Clerk shall certify the passage and adoption of this resolution and shall affix their signature and City Seal and that same shall be entered into the Book of Resolutions.
